## Right to Information Request 30 May 2018

I refer to your request pursuant to the Right to Information Act 2009 (RTI Act) received on 30 May 2018 by Hydro Tasmania. I am authorised to make decisions on behalf of Hydro Tasmania in respect of applications for information under the RTI Act.

### 1. Your Request

Your request was for all information regarding correspondence with Rebecca White dated between 23 May 2018 and 24 May 2018 (Request.)

### 2. Determination and Reasons for Determination of Request

I have undertaken a search of the information held by Hydro Tasmania to locate any records that may be relevant to the request. The information I have determined that is responsive to your request is numbered 1-19 and listed in Annexure A.

I have determined that:
